# AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Donner Lake, near the town of Truckee, Nevada County.

#### **AUTHORIZED USE:**

Removal of an existing recreational pier, not previously authorized by the Commission, and the construction, use and maintenance of a new recreational pier as shown on the attached Exhibit A.

#### LEASE TERM:

Ten years, beginning December 8, 2005.

# SPECIFIC LEASE PROVISIONS:

Insurance:


Liability insurance in the amount of no less than \$300,000.

#### **OTHER PERTINENT INFORMATION:**

- 1. Applicants own the upland property adjoining the lease premises.
- 2. The existing recreational pier was constructed in 1975 by the previous upland owners and was never authorized by the Commission. Applicants are now proposing to remove the existing pier and construct a new recreational pier. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Applicants are now applying for a new Recreational Pier Lease.

3.
