### **GENERAL LEASE - PUBLIC AGENCY USE**

### **APPLICANT:**

Orange County Water District P.O. Box 8300 Fountain Valley, CA 92728-8300

### AREA, LAND TYPE, AND LOCATION:

Public Trust lands in the Bolsa Chica Lowlands, Huntington Beach, Orange County.

### **AUTHORIZED USE:**

Installation and long-term monitoring of a new groundwater well and the long-term monitoring of an existing groundwater well.

### LEASE TERM:

49 years, beginning January 1, 2006.

### **CONSIDERATION:**

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

### OTHER PERTINENT INFORMATION:

- 1. Applicant has a right to use the lands adjoining the lease premises.
- 2. The Applicant, the Orange County Water District (District), has requested a long-term lease from the Commission to continue monitoring an existing groundwater well (BSO2) and for the construction and monitoring of a new groundwater well (BS19) within the Bolsa Chica Lowlands. For many

years prior to the State of California's acquisition of the Bolsa Chica Lowlands, the District has accessed a number of monitoring wells on the property for the purpose of measuring water levels and groundwater salinity. These existing wells were constructed by the California Department of Water Resources and the United States Geological Survey in the 1960s as part of a series of local seawater intrusion investigations.

The construction of the Bolsa Chica Lowlands Wetland Restoration Project will eliminate a number of the wells. However, one existing groundwater well (BSO2) will be preserved and the District wishes to continue monitoring this existing well, along with constructing a new groundwater monitoring well (BS19), to supplement its groundwater quality monitoring network, and to assess any incremental effects of the wetland restoration project on groundwater elevation and salinity conditions.

The District has coordinated with representatives of the United States Fish and Wildlife Service (Service), the Commission's Lessee for construction of the Bolsa Chica Lowlands Wetland Restoration Project. The Service has no objection to the District's project.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 6: Information Collection; Title 14, California Code of Regulations, section 15306.

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

4. The Bolsa Chica lowlands were acquired in 1977 for the specific purpose of restoring the area as tidal wetlands as mitigation for development at the Ports of Los Angeles and Long Beach. The lowlands acquired for the Restoration Project are adjacent to the Bolsa Chica Ecological Reserve that has been identified in 1975 as possessing significant environmental values pursuant to Public Resources Code section 6370, et seq.

Although the Commission considers all lands "significant" by nature of their public ownership, use classifications, specifically designed to protect

the significant environmental values of the area designated, are not assigned unless such lands have been identified as possessing significant environmental values pursuant to Public Resources Code section 6370, et seq. As the affected area was not in public ownership in 1975, it was neither identified pursuant to Public Resources Code section 6370 nor assigned use classifications; therefore, the finding of the project's consistency with the use classification as required by Title 2, California Code of Regulations, section 2954 is not applicable.







Parcel 2 (Well BS19) - A strip of land 6.10 meters (20 feet) wide lying 3.05 meters on each side of the following described centerline: Beginning at a point that bears North 03° 50' 11" West 2430 meters, more or less, from the intersection of the boundary line of the County of Orange and the City of Huntington Beach and the southwesterly right of way line of the Pacific Coast Highway, 27.432 meters (90 feet) wide, as shown on Record of Survey 98-1035, recorded in Book 174 Maps Page 1, Orange County Recorders office; thence North 6.10 meters and the end of said strip.

Parcel 3 (Temporary work area) - A strip of land 9.14 meters (30 feet) wide lying 4.57 meters on each side of the following described centerline: Beginning at a point that bears North 03° 49' 16" West 2425 meters, more or less, from the intersection of the boundary line of the County of Orange and the City of Huntington Beach and the southwesterly right of way line of the Pacific Coast Highway, 27.432 meters (90 feet) wide, as shown on record of survey 98-1035, recorded in Book 174 Maps Page 1, Orange County Recorders office; thence North 15.24 meters and the end of said strip.
