GENERAL LEASE - INDUSTRIAL USE

APPLICANTS:

Venoco, Inc. 5464 Carpinteria Avenue Carpinteria, CA 93103-1423

AREA, LAND TYPE, AND LOCATION:

2.21 acres, more or less, of tide and submerged lands in the Pacific Ocean, near Goleta, Santa Barbara County.

AUTHORIZED USE:

Continued use and maintenance of the Ellwood Pier.

LEASE TERM:

Ten years, beginning June 20, 2005.

CONSIDERATION:

\$107,232 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease. The recommended rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). The adjustment does not obligate the Commission to use the CPI to adjust future rents.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$5,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicants have a right to use the lands adjoining the lease premises.
- 2. On August 31, 1978, the Commission authorized a 25-year lease to Arco and Exxon to maintain the Ellwood Pier (Lease PRC 5515.1). Through a series of assignments, the current Lessees are Venoco, Inc. and Exxon Mobil Corporation. The lease expired on June 20, 2005, and the Lessees have submitted an application requesting a new lease.

The Ellwood Pier is approximately 1,500 feet long and is located in the Pacific Ocean near the city of Goleta in Santa Barbara County. The Lessees utilize the Ellwood Pier to transfer personnel and cargo in support of their offshore oil platform operations. In 1989, the pier was destroyed by fire and was reconstructed entirely of steel and concrete. Between 2002 and 2003, all of the Pier's 188 pilings underwent some form of repair. The pier is inspected every five years, and the next scheduled inspection will occur in 2008.

Practices and procedures for pier operations are included in Venoco's Facility Response Plan, Emergency Action Plan, and Fire Prevention and Preparedness Plan for the Ellwood Complex. Those documents are maintained in the Commission's Long Beach office.

- 3. The Lessees' agreement with the upland owners, by which access to the pier is obtained, has been extended for another five years to September 30, 2010. In the event the Lessees' agreement with the upland owners is not extended beyond 2010, the Lease between the Commission and the Lessees will terminate at that time rather than at the end of the ten year term.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).


