**GENERAL LEASE - PROTECTIVE STRUCTURE USE**

**APPLICANT:**

Michael W. LaFetra, as Trustee of the Michael W. LaFetra Revocable Trust dated 8/12/2000, as amended

**AREA, LAND TYPE, AND LOCATION:**

0.006 acres, more or less, of sovereign lands in the Pacific Ocean, city of Malibu, Los Angeles County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing rock revetment previously authorized by the Commission.

**LEASE TERM:**

Ten years, beginning December 8, 2005.

**CONSIDERATION:**

\$1,650 per annum with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance for combined single limit coverage of no less than \$1,000,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the uplands adjoining the lease premises.
2. On October 28, 1996, the Commission authorized a ten-year General Lease – Protective Structure Use, effective July 1, 1993, to Robert and Palomba Weingarten, for an existing rock revetment adjacent to their upland parcel at Point Lechuza, within the city of Malibu. On

October 7, 1999, the upland parcel was deeded to Michael Wolcott LaFetra, and subsequently quitclaimed on August 20, 2000 to Michael W. LaFetra, Trustee of the Michael W. LaFetra Revocable Trust dated 8/12/2000, as amended (Applicant). Applicant is now applying for a new General Lease – Protective Structure Use for the existing rock revetment.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

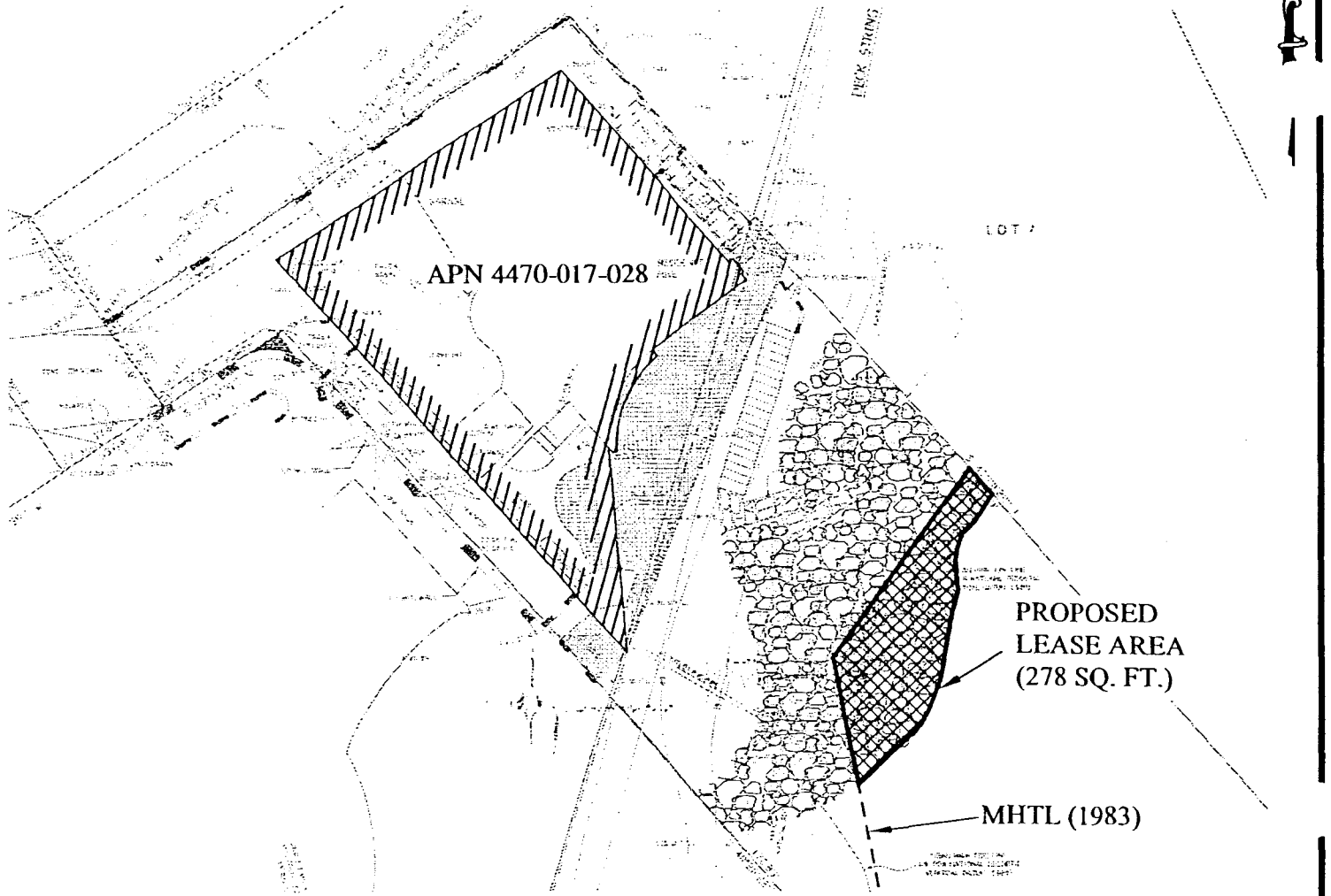

**AUTHORIZATION:**

AUTHORIZE ISSUANCE TO MICHAEL W. LAFETRA, AS TRUSTEE OF THE MICHAEL W. LAFETRA REVOCABLE TRUST DATED 8/12/2000, AS AMENDED, OF A GENERAL LEASE - PROTECTIVE STRUCTURE USE, BEGINNING DECEMBER 8, 2005, FOR A TERM OF TEN YEARS, FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING ROCK REVETMENT ON THE LAND SHOWN ON ON EXHIBIT A AND AS DESCRIBED ON EXHIBIT B ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$1,650 WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM AS PROVIDED IN THE LEASE; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF NO LESS THAN \$1,000,000.

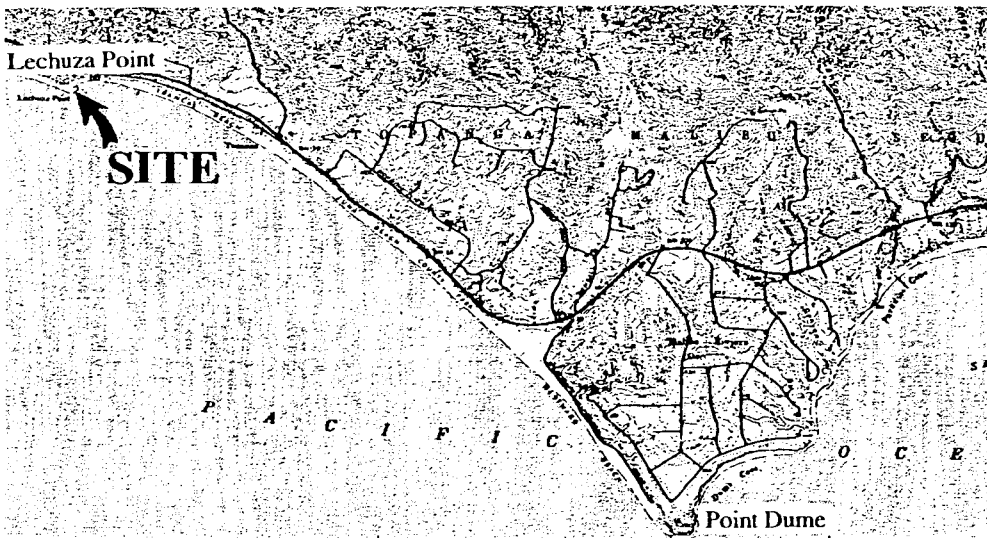
