AREA, LAND TYPE, AND LOCATION:

0.166 acres, more or less, of sovereign lands in the Sacramento River, near Knights Landing, Yolo and counties.

AUTHORIZED USE:

Continued use and maintenance of an existing 8-inch diameter natural gas pipeline which is part of the Knights Landing Eastside Gathering System.

LEASE TERM:

20 years, beginning January 1,1992.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$250 per year, effective January 1, 2007.

OTHER PERTINENT INFORMATION:

- This lease was originally issued to Chevron USA in 1992. In 1993, Chevron USA assigned the lease to Montis Niger, who later assigned the lease to Calpine Corporation, who subsequently assigned the lease to CPN Pipeline Company.
- 2. CPN Pipeline Company operates this pipeline system under the guidelines of CPN's Pipeline Integrity Management System and has not experienced any incidents within this pipeline crossing. This pipeline is regulated by the Department of Transportation (DOT), Office of Pipeline Safety; the last
