LESSEE:

Santa Fe Aggregates, Inc. P. O. Box 3042 Modesto, CA 95353

AREA, LAND TYPE, AND LOCATION:

12.32 acres, more or less, of sovereign lands located in the historic bed of the Tuolumne River, near Waterford, Stanislaus County.

AUTHORIZED USE:

Stockpiling of processed and unprocessed gravel; use and storage of related equipment; and a right-of-way crossing.

LEASE TERM:

25 years, beginning December 30, 1992.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$1,221 per year to \$5,625 per year, effective December 30, 2006.

OTHER PERTINENT INFORMATION:

- In 1977, the Commission authorized a 15-year General Lease Industrial Use to M. J. Ruddy, Jr. with a ten year renewal option. In 1992, the Commission terminated the lease and issued a new 25-year lease to M. J. Ruddy & Son, Inc. beginning December 30, 1992. A review of the rent has not been conducted on the lease since 1997.
- 2. On March 22, 1995, the Articles of Incorporation for M.J. Rudy and Son, Inc., were amended to change the name of the corporation to Santa Fe Aggregates, Inc.




