#### PARTY:

#### **BACKGROUND:**

The State Lands Commission (CSLC) owns its Huntington Beach field office located at 1700 Pacific Coast Highway. This office is located in a prominent area of Huntington Beach along the Pacific Coast Highway. The building was constructed in the early 1940's, with total area of 3,780 square feet and is in need of many repairs, as well as accessibility improvements. Additionally, the buildings appearance and grounds are in disrepair and considered a visual nuisance to the community.

The field office is staffed by four oil and gas inspectors as part of the CSLC pollution and safety inspection efforts on State leases in surrounding counties. The field office is also equipped with an oil laboratory where crude oil from State leases is analyzed as part of the Commissions crude oil royalty program. The office is strategically located in Huntington Beach and is immediately adjacent to State oil and gas leases in the area. The office is also used as a base for staff working on the Bolsa Chica Wetlands Restoration project

#### PROPOSED ACTIVITY:

The Executive Officer requests delegation of authority to solicit bids, award and execute agreements to repair the Huntington Beach Field Office. The project cost is estimated at \$75,000.

The method will be an Invitation for Bid (IFB) Public Works contract with the lowest cost proposal meeting all requirements and criteria stated in the IFB. All bids will be available for public inspection at the Commission's Sacramento office.
