Kimberlee M. Krouse, Trustee of the Virginia Baker Personal Residence Trust Dated February 4, 2005

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, Huntington Beach, Orange County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing boat dock and access ramp.

#### LEASE TERM:

Ten years, beginning March 1, 2007.

#### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:


Liability insurance in the amount of no less than \$300,000.

#### OTHER PERTINENT INFORMATION:

- 1. Applicant owns the uplands adjoining the lease premises.
- 2. On February 12, 1997, the Commission approved the issuance of a Recreational Pier Lease to Virginia L. Baker for a ten-year term for the continued use and maintenance of an existing boat dock and access ramp, effective as of March 1, 1997. On February 4, 2005, the upland parcel adjoining the lease premises was transferred to Kimberlee M. Krouse, as Trustee of the Virginia Baker Personal Residence Trust. Ms. Krouse is now applying for a new Recreational Pier Lease.

- 3. Applicant qualifies for a Recreational Pier Lease as the Trustee of a Trust comprised of natural persons who have improved the littoral land with, and use the upland for, a single family dwelling.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




