REVISION OF RENT

LESSEE:

Noble Yacht Group, Inc. 4651 Lincoln Drive Concord, California 94521

AREA, LAND TYPE, AND LOCATION:

0.32 acres, more or less of sovereign lands in the San Joaquin River, at Little Tinsley Island, San Joaquin County.

AUTHORIZED USE:

Continued use and maintenance of four uncovered docks, a covered patio dock, an access ramp, timber bulkhead, and bank protection.

LEASE TERM:

15 years, beginning July 1, 1997.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$1,742 per year to \$1,540 per year, effective July 1, 2007.

OTHER PERTINENT INFORMATION:

- 1. On July 11, 1997, the Commission authorized the issuance of a 15-year General Lease Fecreational Use to Noble Yacht Group, Inc., for the continued use and maintenance of five existing uncovered floating boat docks, a covered floating patio dock, an access ramp, timber bulkhead, and bank protection.
- 2. The area lying between the docks and the uplands has silted in and vegetated leaving the area unavailable for the docking and mooring of
