CONTINUATION OF RENT

LESSEE:

Southern California Edison Company

AREA, LAND TYPE, AND LOCATION:

Two parcels of school land within the South ½ of Section 16, Township 12 North, Range 7 East, SBM, near the town of Baker; and within the South ½ of the Southeast ¼ of Section 36, Township 16 North, Range 11 East, SBM (Tract 37) near the town of Halloran Springs, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of an existing 115 kilovolt (kV) electrical transmission line.

LEASE TERM:

20 years, beginning May 23, 2007.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$990 per year, effective May 23, 2012.

OTHER PERTINENT INFORMATION:

1. On June 28, 2007, the Commission authorized a 20-year General Lease – Right-of-Way Use to Southern California Edison Company. That lease will expire on May 22, 2017. Southern California Edison Company inspects its electrical transmission line annually. No violations for this transmission line have been reported.

2. The staff recommends that the Commission find that the subject continuation of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment,

and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

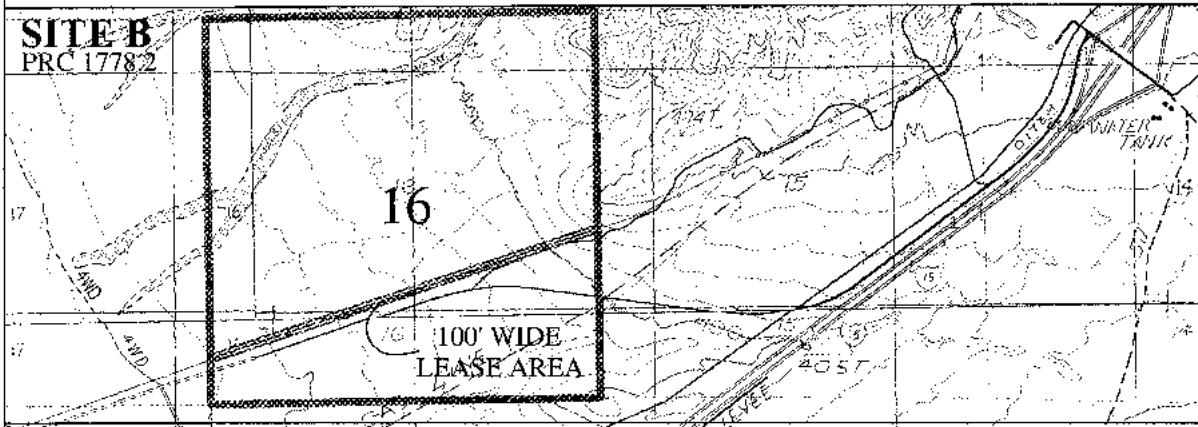
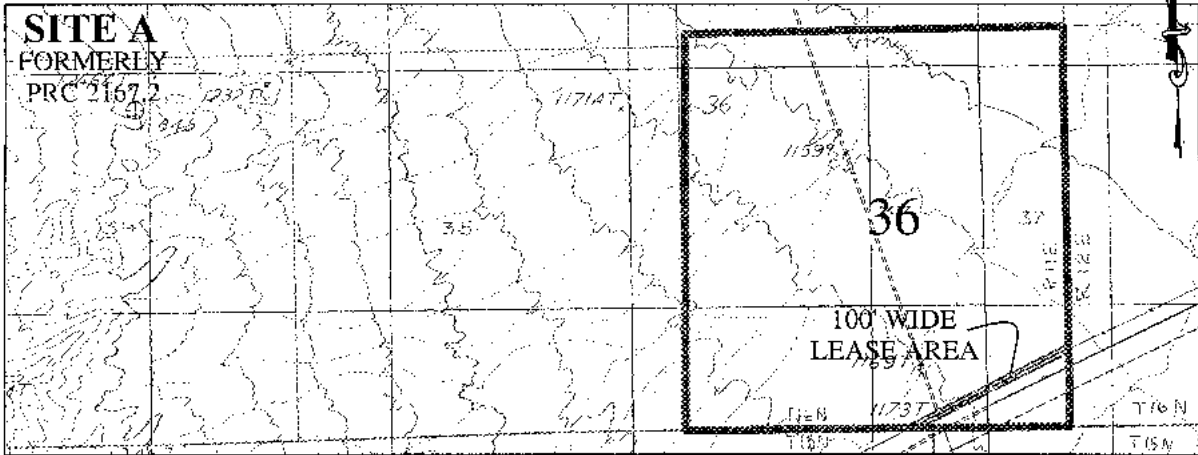

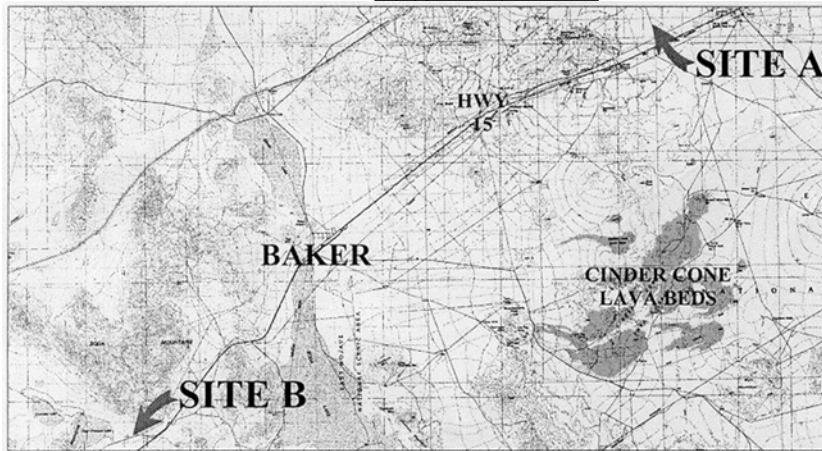
SITE
