REVISION OF RENT

LESSEE:

Connolly-Pacific Co. 1925 West Pier D Street Long Beach, CA 90802

AREA, LAND TYPE, AND LOCATION:

Sovereign land located in the Pacific Ocean, offshore of Santa Catalina Island, Los Angeles County

AUTHORIZED USE:

Continued use and maintenance of an existing stiff-leg crane and six moorings used for barge and tugboat tie-ups.

LEASE TERM:

44 years, beginning January 1, 1991.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends rent be revised from \$13,508 to \$17,303 per year, effective January 1, 2013.

OTHER PERTINENT INFORMATION:

- On June 27, 2000, the Commission authorized a General Lease Industrial Use to Connolly-Pacific Co., for a term of 44 years beginning January 1, 1991. The lease will expire on December 31, 2034.
- 2. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).




