REVISION OF RENT

LESSEE:

Kern River Gas Transmission Company

AREA, LAND TYPE, AND LOCATION:

5.4 acres, more or less, of State-owned school land within a portion of Section 36, Township 14 North, Range 6 East, SBM, near Daggett, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of one 36-inch-diameter steel natural gas pipeline.

LEASE TERM:

19 years, beginning August 1, 2002.

CONSIDERATION:

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff reviewed the rent under this lease and recommends that rent be revised from \$3,384 per year to \$8,460 per year, effective August 1, 2017.

OTHER PERTINENT INFORMATION:

1. On August 1, 2002, the Commission authorized a General Lease – Right-of-Way Use to Kern River Gas Transmission Company for a term of 19 years beginning August 1, 2002 ([Calendar Item C1, August 14, 2002](#)). The lease will expire on July 31, 2021.
2. On July 1, 2014, the chargeable rental rate per diameter inch per lineal foot of pipeline, conduit, or fiber optic cable was increased from \$0.02 to \$0.05 (Cal. Code Regs., tit. 2, § 2003, subd. (a)(4)). Staff conducted the rent review called for in the lease and recommends the rent be increased per the updated rate per diameter inch per lineal foot from \$3,384 per year to \$8,460 per year, effective August 1, 2017.

3. The lease requires internal and external inspections, a subsidence hazard reassessment, and cathodic protection inspections. Commission staff received and are currently reviewing a summary of the lessee's 2015 internal inspection and have requested additional details. Commission staff also requested information concerning subsidence hazards and cathodic protection results.
4. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
5. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).

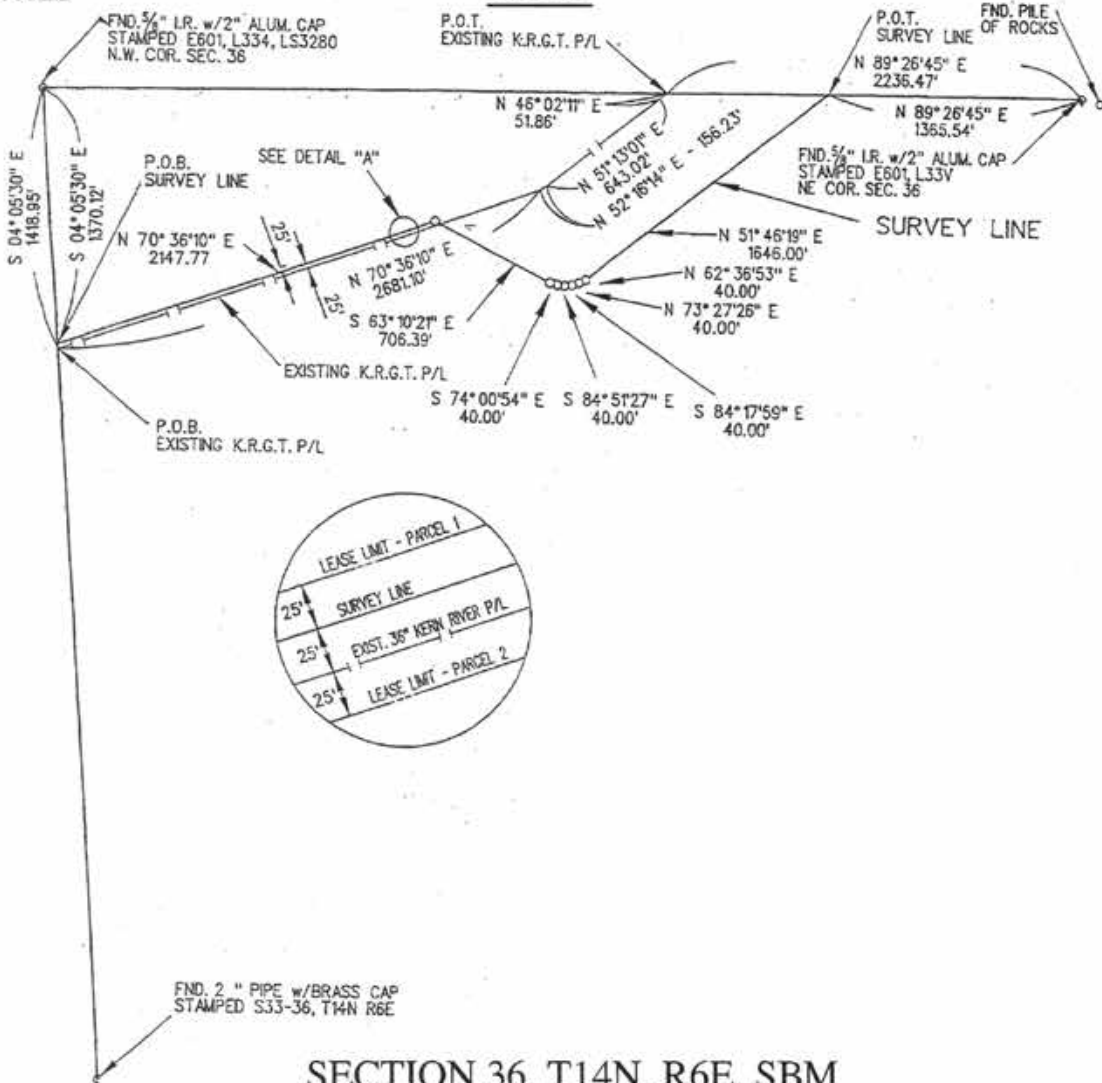
