# AMENDMENT OF LEASE AND REVISION OF RENT

### LESSEE:

John A. McIntosh and Lynne B. McIntosh, Trustees Under Revocable Trust Agreement Dated May 27, 1988

### AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 6740 Powderhorn Lane, near Tahoma, Placer County.

### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier and one mooring buoy.

### LEASE TERM:

10 years, beginning December 5, 2012.

### **CONSIDERATION:**

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$1,177 per year to \$766 per year, effective December 5, 2017.

### PROPOSED AMENDMENT:

Amend the lease to replace the existing Exhibit A, Land Description, and Exhibit B, Site and Location Map, with the attached Exhibit A, Land Description, and Exhibit B, Site and Location Map (for reference purposes only). All other terms and conditions of the lease shall remain in effect without amendment.

## STAFF ANALYSIS AND RECOMMENDATION:

### **Authority:**

Public Resources Code sections 6005, 6216, 6301, 6501.1, 6503, and 6503.5; California Code of Regulations, title 2, sections 2000 and 2003.

### Public Trust and the State's Best Interests Analysis:

On December 5, 2012, the Commission authorized a 10-year General Lease – Recreational Use to John A. McIntosh and Lynne B. McIntosh,

Trustees under Revocable Trust Agreement dated May 27, 1988, for an existing pier and one mooring buoy (<u>Item C01, December 5, 2012</u>). That lease will expire on December 4, 2022.

Staff conducted the rent review called for in the lease and recommends the rent be revised from \$1,177 per year to \$766 per year based on changes to the lease (impact) area for the pier and application of the Lake Tahoe Benchmark. Staff also recommends the lease be amended to reflect the new reduced lease area.

The lease does not alienate the State's fee simple interest or permanently impair public rights. The recommended action will not substantially interfere with the Public Trust needs at this time and at this location. For these reasons, staff recommends finding the proposed action is in the best interests of the State.

### OTHER PERTINENT INFORMATION:

- 1. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 2. Amendment of the lease to make an adjustment in the lease area and approving the revision of the rent are not projects as defined by the California Environmental Quality Act because they are administrative actions that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).

EXCEPTING THEREFROM any portion lying landward of elevation 6223 feet LTD on the shoreline of said Lake Tahoe.


### PARCEL 2-BUOY








LAND DESCRIPTION PLAT PRC 4357.1, MCINTOSH PLACER COUNTY
