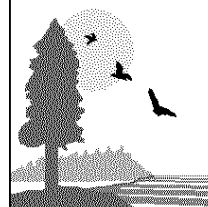

Mr. Boggiano;

I am reporting on the status of public trust lands legislatively granted to the City of San Mateo. The boundaries of the land grant is largely submerged land with certain long standing improvements along the shoreline such as a bike path, a portion of decommissioned landfill turned into a passive park, a portion of a river levee, and a wastewater pump station. The City of San Mateo does not generate any revenue from this land and there are no leases in place. We do not have any funds or accounts related to this land as there are no real expenditures or revenues to account for. There is also no dredging taking place on this land.
