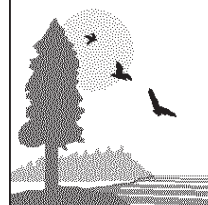

Yes. Fuel Dock Pier was removed in FY15 and replaced in FY16 - FY17. Total project is estimated to be \$3.2 million. In FY18, a project to renovate the ferry terminal will begin. The total project is estimated to be over \$6 million and will be completed by FY19.
