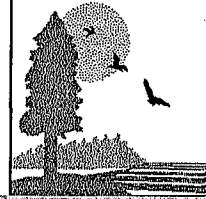

Following is a brief explanation to go with the request for further information required by you in regards to the 2016/2017 lands Commission Reports we have filed with you.

The figures used to fill out the Lands Commission Standardized Yearly Report are arrived at using figures from our Sage Accounting program for the expenses section, and from our Marina program for the Tidelands revenue section.

As in the past years, we have used a percentage of the utility bills that pertain to the actual expense, ie, PG&E, Waste Management, etc. We also use a percentage of the labor cost of our maintenance employee on the payroll.

The Tidelands revenues are exactly as paid and entered into the Marina program for any fiscal period.
