SIR:

I have the honor to herewith submit a report covering the work of this office for the term ending August 1, 1926.

DURING THE PAST BIENNIUM

Fees and royalties amounting to \$10,964 were collected by the Surveyor General and Register of the State Land Office, as provided by sections 501 and 3574 of the Political Code and chapter 303, Statutes of California, 1921, and paid into the state treasury and placed to the credit of the general fund.

16,008 acres of state school lands were leased for a rental of \$3,778 under the provisions of chapter 493, Statutes of California, 1917.

22,486 acres of lieu school lands were sold through the sale of scrip purchased under the provisions of section 3408d of the Political Code for the sum of \$146,161, an average of \$6.50 per acre.

Public auction sales of school lands were held under the provisions of chapter 207, Statutes of California, 1919, in the counties of Los Angeles, Tehama, Lake, Mendocino, Monterey, Santa Clara, Lassen, Mono, Inyo, San Diego, Imperial, San Bernardino, Riverside, San Luis Obispo and Kern, 48,412 acres being sold for \$158,999, an average of \$3.28 per acre.

592 applications to purchase 72,190 acres of state lands were filed.

1392 reports of county treasurers, made under the provisions of section 3422 of the Political Code, showing the receipt of \$160,401 paid for state lands, were received and entered on the records of this office, as provided in section 3423 of the Political Code.

7740 acres of lake lands were leased for a rental of \$22,100 under the provisions of chapter 612, Statutes of California, 1911.

47 lists and patents conveying 20,748 acres of land from the United States to the state were recorded in this office, as provided in section 3406 of the Political Code.

561 certificates of purchase for 67,834 acres of state lands were issued under the provisions of section 3514 of the Political Code.

414 patents for 61,963 acres of state lands were issued under the provisions of section 3519 of the Political Code.

199 land surveyors' licenses were issued under the provisions of chapter 247, Statutes of California, 1907.

County registrars of land titles in seventeen counties in the state operating under "An act to amend an act entitled 'An act for the certification of land titles and the simplification of transfer of real estate,' approved March 17, 1897," Statutes of California, 1915, page 1932, reported to this office the number of registrations and of certificates of title issued, which reports were embodied in reports made by this office under the provisions of chapter 800, Statutes of California, 1917.

43 duplicate certificates of purchase were issued under the provisions of section 3518 of the Political Code.

68 certificates of status of state lands, 135 certified copies of records and 46 certified copies of records of patents were issued.

225 indemnity state selections were made under the provisions of section 3398 of the Political Code.

150 certified lists of lands sold by the state were issued under the provisions of section 3659 of the Political Code

26 statements of delinquencies were issued as provided by section 3546 of the Political Code.

Surveys, maps and tablings made under the provisions of chapter 612, Statutes of California, 1911, amounting to 9 in number, were checked.

1 survey with map and tabling made under the provisions of chapter 490, Statutes of California, 1915, was checked.

2,748,390 feet of timber were sold from 360 acres of state school lands in National forests, for \$6,500, an average of \$18 per acre, and the state still retains the land which has a value of \$6.50 per acre as scrip.

10,000 letters have been written during the two years.

24 lists of persons licensed as land surveyors were transmitted to each of the 58 county recorders in the state as provided by section 4 of chapter 247, Statutes of California, 1907, a total of 1392 lists being transmitted.

October 15, 1925.

Pursuant to the provisions of chapter 800, Statutes of California, 1917, I beg to report that according to reports received, certificates of title have been issued pursuant to the registration of land titles under "The Torrens Law" in eighteen of fifty-eight counties, as follows:

Alameda County – 94 certificates issued to August 1, 1925.
Fresno County – 4 certificates issued to August 1, 1925.
Humboldt County – 182 certificates issued to August 1, 1924. No report was received from the Registrar of titles in Humboldt County for the year 1924-1925.
Imperial County – 268 certificates issued to August 1, 1925.
Inyo County – 5 certificates issued to August 1, 1925.
Kern County – 48 certificates issued to August 1, 1925.
Los Angeles County – 34,139 certificates issued to August 1, 1925.
Orange County – 3897 certificates issued to August 1, 1925.
Riverside County – 148 certificates issued to August 1, 1925.
San Bernardino County – 1350 certificates issued to August 1, 1925.
San Diego County – 2500 certificates issued to August 1, 1925.

The Torrens act provides that upon the original registration of any land, a sum equal to one-tenth of one per cent of the assessed value of the land including permanent improvements thereon as the same were valued for county taxation the last time said land and permanent improvements of either thereof were assessed for county taxes next preceding the filing of the petition shall be collected by the registrar and paid to the State Treasurer to be credited to the "Torrens Title Assurance Fund." The books of the State Treasurer show that on August 1, 1925, the "Torrens Title Assurance Fund" contained State of California Harbor Improvement 4 per cent bonds having a face value of \$25,000, which were purchased for the benefit of said fund, for the sum of \$27,308.23, and that the amount of cash in said fund on August 1, 1925, was \$791.96.

LAND TITLE LAW

October 1, 1926.

Pursuant to the provisions of chapter 800, Statutes of California, 1917, I beg to report that according to reports received, certificates of title have been issued pursuant to the registration of land titles under "The Torrens Law" in eighteen of fifty-eight counties, as follows:

- Alameda County – 103 certificates issued to August 1, 1926.
- Fresno County – 6 certificates issued to August 1, 1926.
- Humboldt County – 198 certificates issued to August 1, 1926.
- Imperial County – 297 certificates issued to August 1, 1926.
- Inyo County – 5 certificates issued to August 1, 1925. No report was received from the Registrar of titles in Inyo County for the year 1925-1926.
- Kern County – 55 certificates issued to August 1, 1926.
- Los Angeles County – 39,458 certificates issued to August 1, 1926.
- Orange County – 4271 certificates issued to August 1, 1926.
- Riverside County – 152 certificates issued to August 1, 1926.
- San Bernardino County – 1619 certificates issued to August 1, 1926.
- San Diego County – 2689 certificates issued to August 1, 1926.
- San Francisco County – 9 certificates issued to August 1, 1926.

The Torrens act provides that upon the original registration of any land, a sum equal to one-tenth of one per cent of the assessed value of the land including permanent improvements thereon as the same were valued for county taxation the last time said land and permanent improvements of either thereof were assessed for county taxes next preceding the filing of the petition shall be collected by the registrar and paid to the State Treasurer to be credited to the "Torrens Title Assurance Fund." The books of the State Treasurer show that on August 1, 1926, the "Torrens Title Assurance Fund" contained State of California Harbor Improvement 4 per cent bonds having a face value of \$25,000, which were purchased for the benefit of said fund, for the sum of \$24,250.19, and that the amount of cash in said fund on August 1, 1926, was \$1,982.74.
