## NOTICE OF PUBLIC REVIEW AND INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

A Mitigated Negative Declaration (MND) has been prepared by the California State Lands Commission (CSLC), as lead agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.), in response to an application submitted by Chevron Products Company for the Chevron Long Wharf Maintenance and Efficiency Project (Project). The MND is in compliance with the requirements of CEQA, the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.), and CSLC Regulations (Cal. Code Regs., tit. 2, § 2901 et seq.). This Notice fulfills a State noticing and review requirement for the CSLC.

**Project Title**: Chevron Long Wharf Maintenance and Efficiency Project

Project Location: Richmond, Contra Costa County, California

**Project Description**: The proposed Project would authorize Chevron Products Company to implement modifications to improve the reliability and efficiency of the Richmond Refinery Long Wharf (Long Wharf), comply with Marine Oil Terminal Engineering and Maintenance Standards (MOTEMS) requirements, and enhance crew and operator safety. The Project site is in San Francisco Bay adjacent to the Chevron Refinery in Richmond. None of the Project changes, which would modify Long Wharf Berths 1, 2, 3, and 4 (see below), is anticipated to change throughput levels or result in an increase in the number or size of ships calling at the Long Wharf.

The CSLC originally issued an MND for the proposed Project on August 5, 2016. The CSLC is recirculating the MND pursuant to State CEQA Guidelines section 15073.5 because the August 2016 MND has been revised after public notice of its availability, and in response to comments

received during the 30-day comment period, to: include new information about emissions from tug boats proposed for use in Project activities; update mitigation measures for impacts to protected species to reflect further consultation with the California Department of Fish and Wildlife; include a discussion of updated National Marine Fisheries Service standards for underwater noise released in July 2016; clarify and amplify the proposed changes to minimize stray lighting at the Long Wharf, including using shielded 3000 Kelvin color temperature light-emitting diode (LED) lighting that minimizes the blue spectrum; and clarify the Project purpose.
